Appendix D: Agency Coordination Plan





Purpose

The Agency Coordination Plan (ACP) communicates CTDOT coordination milestones for regional, state, and federal agency participation and to identify opportunities for interactive dialogue in the Planning and Environmental Linkages (PEL) process. The PEL process is designed to improve information sharing and early consultation among state and federal transportation and resource agencies, thereby reducing, or even eliminating, duplication of work in future planning and National Environmental Policy Act (NEPA) and Connecticut Environmental Policy Act (CEPA) processes. The ACP guided the agency coordination activities at various milestones of the GHMS PEL study and will support the agency coordination process to be followed on any future NEPA actions that may be required based on outcomes of the PEL study.

Key Components

- 2. Summary of Anticipated Agency Roles and Coordination Outcomes
- 3. Summary of GHMS Agency Coordination Meetings (Meeting Types, Dates, Focus of Discussion etc.)

Agency Coordination

As the lead agency, CTDOT coordinated with federal, state, and local agency partners at various milestones throughout this study.

CTDOT worked with appropriate agency partners to establish the study's framework, establish need statements, define the preliminary universe of alternatives, eliminate unreasonable alternatives, and document planning decisions.

Resource Agency Partners - GHMS Phase 1 and Phase 2

CTDOT, selected modal agencies within the United States Department of Transportation (USDOT)¹ and the United States Department of Housing and Urban Development (USHUD) provides input during the PEL process related to the study approach, alternatives development, and identification of performance measures used to evaluate them. Resource Agency Partners do not formally "approve" the PEL outcomes and may only confirm their involvement in various phases of the PEL study process but acknowledge that the outcomes of the PEL process and study are an acceptable baseline for public outreach, initial resource identification and initial alternatives analysis and screening for the NEPA process. The role of each agency is identified below in Table 1. Resource Agency Partner points of contact are provided in Appendix D.1 – Agency Partner Contact Information.

Study Timeline and Collaboration Touch Points

To facilitate agency involvement in the GHMS, CTDOT identified collaboration touch points aligned with key GHMS milestones when agencies can advise on the study process. Advisement was through meetings to solicit feedback on study findings. Collaboration touch points occurred when study activities and/or milestones resulted in important decisions affecting the study process and its outcomes. Through the COVID-19 pandemic, the GHMS Study Team facilitated communications through virtual platforms and developed tools to foster collaboration with Agency Partners.

The GHMS was organized into two phases. Phase 1 focused on the assessment of existing and future base conditions, identifying deficiencies and study needs, developing a Universe of Alternatives and establishing high-level fatal flaw screening criteria to screen the alternatives for inclusion in Phase 2.


Figure 1: GHMS Phase 1 Timeline and Collaboration Touch Points

The outcomes of Phase 1 included Need Statements for the overall study area and individual corridors and a screened Universe of Alternatives that was advanced to the Phase 2. A sequential timeline of Phase 1 along with identified collaboration touch points is provided in Figure 1.

Jurisdiction/Focus

Phase 2 conducted detailed screening of alternatives that passed the Phase 1 high-level fatal flaw screening and evaluated them against appropriate performance-based screening criteria aligned with the overall vision and GHMS study-specific needs. Phase 2 defined potential transportation/ mobility improvement programs based on immediacy of mobility benefits and funding opportunities available along with a project implementation plan to advance appropriate projects through the subsequent NEPA requirements, as applicable.
